## **COVE VIRTUAL MEETING MINUTES**

The Construction Oversight and Value Engineering Committee (COVE) monthly meeting convened on Thursday, August 20, 2020 at 8:00 a.m., virtually WebEx.

A quorum was established and Chair Ksenia Merck called the meeting to order at 8:06 a.m.

## **APPROVAL OF MINUTES:**

The minutes from June 18, 2020 were presented and approved unanimously by the committee.

## **CHAIR COMMENTS:**

Ksenia Merck thanked OCPS Facilities Services for their continuous hard work during the pandemic. Sandra Roopwah was recognized as well for the hard work she provided to COVE as she is no longer with OCPS. Tamara Andrews was welcomed as her replacement.

John Morris introduced Jad Brewer as our Planning & Real Estate Management attorney.

## **DEPARTMENTAL REPORTS:**

## 1. Sales Tax & Impact Fees Update

Dale Kelly provided an update on sales tax revenue projections along with historical sales tax collection information and the impact from COVID-19. It was stated that 50% of the sales tax revenue collected by Orange County is generated by tourism.

Judith Padres provided the impact fee collection numbers for the past three years. There were no questions or concerns.



## 2. 10-Year Capital Improvement Plan

Judith Padres provided the committee with the Long Range Capital Improvement Plan for additional schools and presented the FY 2021 Tentative Capital Budget.

Jeff Hart asked if project priorities changed from last year due to the decrease in funding.

Judith Padres responded yes, the Advance Planning committee revised the priorities based on current needs and funding.

Jeff Hart asked how priorities were determined.

Dale Kelly responded that the process to prioritize didn't change from last year. The list is based on development, growth and needs. The draft budget provides capital funding that supports the schedule for school opening recommended by the Advance Planning committee.

Jeff Hart requested a comparison of the current plan to the previous year's plan.

John Morris acknowledged that we will provide at the September COVE meeting.

## 3. Master Schedule Update

Rory Salimbene discussed the Master Schedule for upcoming projects scheduled for commencement through 2025. Rory noted that the list did not include either functional equity projects or additional comprehensive projects planned for older schools. Both project groups will be added once preliminary planning and prioritization is completed.

The Chair asked if Facilities have started a discussion on design changes due to COVID-19, such as touchless devices, filters, HVAC system.

Rory responded yes, we're evaluating everything and results of the evaluation will be shared with the committee.

The Chair would like a future presentation on design guideline modifications in response to COVID-19.

## 4. Project Status Report

Mark O'Connor called attention to the project status report commencing on page 30. Since the last meeting we have entered a new fiscal year and the changes from FY20 to FY21 are reflected in column F2 of the report. Some of the revisions reflect adjustment in escalation per the scheduled construction period while there are other instances where the budget is lowered to reflect cost projections as projects are near completion.



The increase for site 132-M-W-4 is largely due to site conditions that arose during the design phase and not foreseen during planning. The technical schools show the greatest change and the overall program requirements are being reviewed for these.

Of the projects currently in closeout, many are scheduled to be closed this September. Capital Renewal projects for Boone High, Chain of Lakes Middle and Liberty Middle have been closed since the preparation of the report.

During our last meeting we were asked to report on projects at Boone HS. The budgets for these projects amount to \$60.5M and is made up of Capital Improvement, Capital Renewal and Digital Curriculum projects.

Craig Jackson reported there are currently 9 projects under construction totaling approximately \$441 million. The committee was briefed on projects under construction, closeout and the design phase.

Craig Jackson reported there are 41 active Capital Renewal projects currently in progress totaling approximately \$143 million. This is an increase of \$3.4 million since the last report. There are currently 19 projects in planning, 3 in design, and 19 under construction.

Jeff Hart asked if there were any issues with current construction projects due to COVID-19.

Craig Jackson responded, there are no issues with current projects due to COVID-19.

Jeff Hart asked the status on Jones High School Capital Renewal project.

Craig Jackson responded, the project is on schedule to finish in November 2020.

Rory Salimbene added, the roof project would extend the completion date to the end of next year.

## 5. Change Orders Report

Ed Ames reported that there were no significant change orders or amendments to report for the Month of May. Significant change orders are defined as orders greater than \$200K in value or 120 days in extended time.

## 6. Presentations

Lauren Roth provided a sneak peek video of the new Magnolia School.

## 7. Discussion/Adjournment

Curriculum & Digital Learning provided the cost information requested by Pat Knipe at the last COVE meeting.

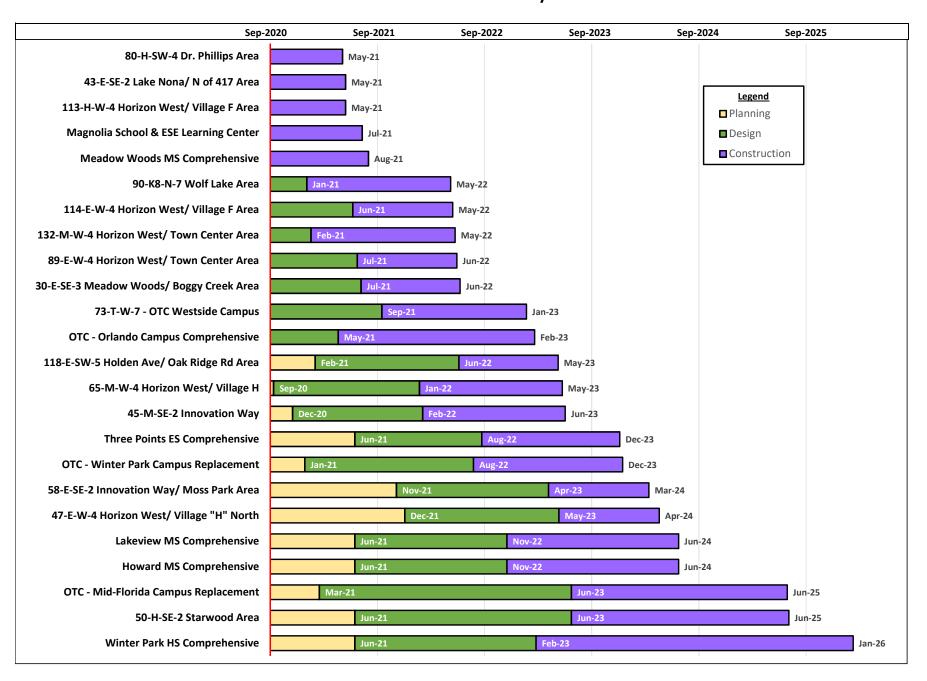

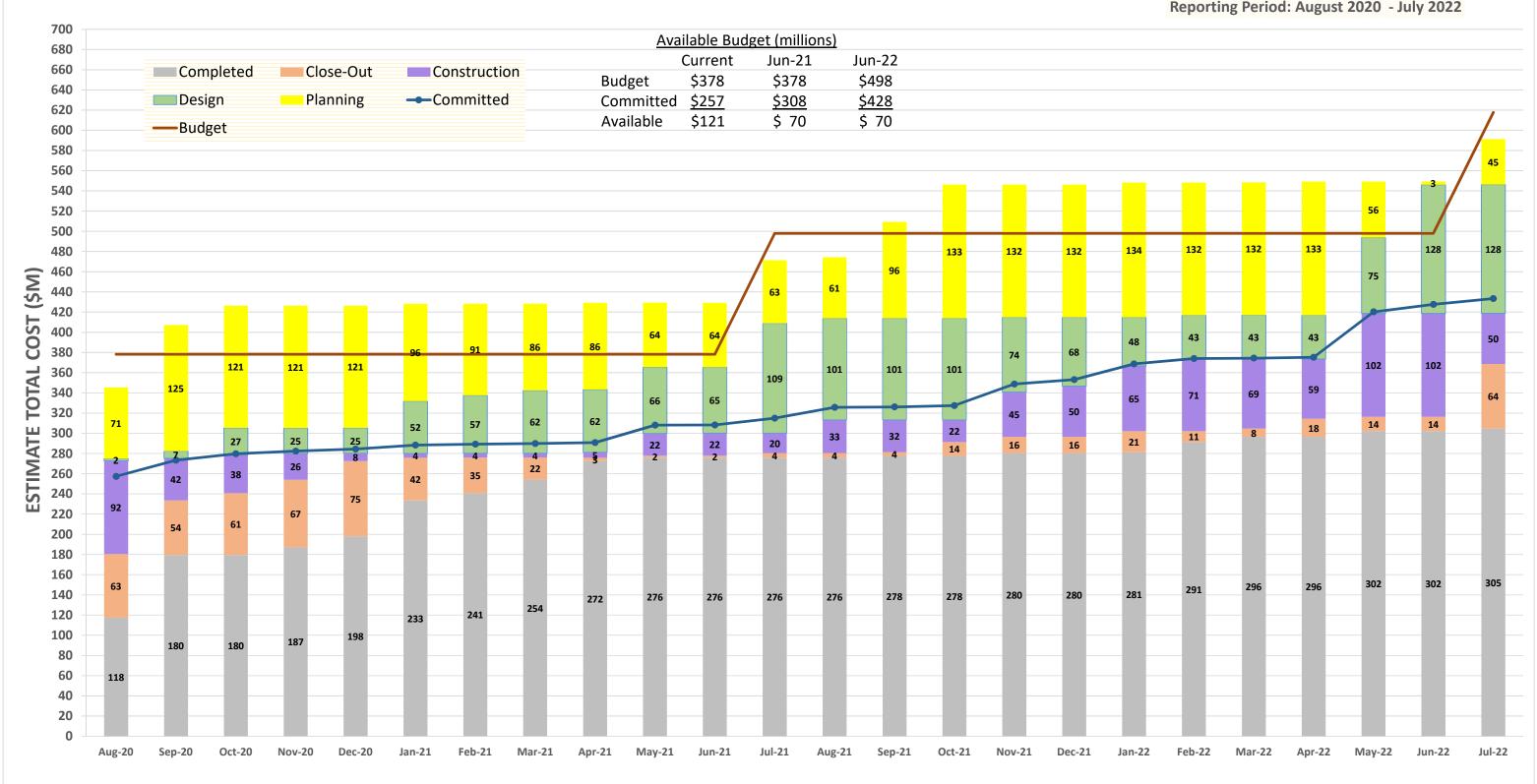

# **Capital Renewal Forecast**

Reporting Period: August 2020 - July 2022



## Construction Update as of September 17, 2020

We continue with 9 projects under varying degrees of construction, amounting to approx. \$441 M.

## Three (3) Comprehensive Projects = \$62,442,000

Acceleration West (Comprehensive Renovation)

Construction NTP received in October 2019 and includes 3 phases. Phase 1 of this project received their TCO on July 22, 2020, which included renovation of building 100 (administration), building 300 (classrooms), and building 500 (classrooms). This work finished 6 weeks behind schedule, due to delays caused by COVID-19 and the safety method of T & G Constructors to have workers social distance during construction.

Phases 2 and 3 included complete renovation of building 400 (Media Center and Classrooms) and building 200 (Cafeteria Renovation). TCO was received August 18, 2020 for phases 2 and 3. This work finished 3 weeks behind schedule, due to delays caused by COVID-19 and the safety method of T & G Constructors to have workers social distance during construction.

A fourth phase was added to include a single point of access not previously included in the comprehensive project. This phase is anticipated to be complete by the end of September 2020.

## • Meadow Woods MS (Comprehensive Renovation)

Construction NTP received in January 2020 and includes 5 phases. Phase 1 is complete and included renovation of building 600 (music), building 700 (gymnasium), building 800 (cafeteria), and replacement of tennis courts. Phase 1 received TCO on August 13, 2020. Four weeks behind schedule, delays occurred due to the late delivery of the Trane Air Handlers, due to COVID-19.

## Site 80-H-SW-4 (New Relief HS – Dr. Phillips area)

Early site package construction NTP was received in September 2019 and the main building package in December 2019.

Final roof membrane is now complete atop all campus buildings except Buildings 900 and 1000. Interior CMU, metal framing, drywall, interior and exterior windows are ongoing in all buildings; roof drains, HVAC ductwork and restroom plumbing rough-ins also ongoing; paint and ceiling grid is recently underway. Chilled water piping and water and sanitary piping is progressing around building perimeters and through the courtyard, and should be completed in early September 2020. Installation of courtyard stairs and hollow-core landings continue. Grading for the sports fields and installation of fire access road continues.

Project is on schedule for completion in May 2021.

## Capital Renewal Update as of September 17, 2020

There are 40 active projects (19 large, 13 intermediate, 8 small) currently in progress for improvements at 64 sites. Bonneville ES, Boone HS, Jones HS, and Ocoee MS have two projects each. ## **Planning**

We currently have 19 projects being planned at 53 sites; five projects are multi-site projects, one for replacing chillers at two campuses, one for reroofing at four campuses, two for reroofing at two campuses each, one for replacing intrusion detection at 26 campuses, and one for replacing fire alarm/intercom/security cameras at 38 campuses. This represents a net no change in number of projects since the last report – separate chiller replacement projects at *Jackson MS* and *Lake Sybelia ES* were bundled into a single project, two Multiple Site Low Voltage projects were added, and 1 project reached substantial completion. The current estimated budget for projects being planned is \$70.2M, which is an increase of \$23.5M from the last report.

## Design

We currently have 2 projects in design at 2 sites, which is a net decrease of 1 project from the last report. *Ocoee MS* (Fire Alarm & Intercom) was unbundled. Ocoee MS (Fire Alarm) remained in Design. *Ocoee MS* (Intercom) and *Wolf Lake MS* (CEP Modifications) commenced construction since the last report. The current estimated budget for projects in design is \$2.3M, which is a decrease of \$2.6M due to the *Ocoee MS* (Intercom) and *Wolf Lake MS* (CEP Modifications) projects moving to construction.

We are finalizing the Guaranteed Maximum Price (GMP) proposals and construction commencement is expected in the next three months for the following projects:

- Bonneville ES – Phase I, Envelope and Electrical

## Construction

We currently have 19 projects in construction at 18 sites, which is no change since the last report. These include 10 large, 4 intermediate and 5 small projects with a total budget of \$92.0M. The total estimated cost of projects in construction increased by a net \$0.6M, due to a budget revision for *Ridgewood Park ES* (Paving), projects at *Ocoee MS* (Intercom) and *Wolf Lake MS* (CEP Modifications) commencing construction and projects at *East River HS* (Chiller Renewal) and *Piedmont Lakes MS* (Handrails) achieving substantial completion.

Projects at Jones HS and Olympia HS exceed \$10M in construction costs; a detailed scope description for each is included with this report. All active projects in construction are expected to be completed in 2020, except for *Wolf Lake MS* (CEP Modifications), which is expected to be complete in January 2021.

## **Overall Program**

The included Capital Renewal Forecast indicates a balance of unused capital renewal funds through the end of FY 2021 of approximately \$70M. The forecasted budgets shown are based on the Adopted Budget Summary, 2020-2021, dated 9/8/20. Future renewal needs are based on renewal projections identified in the 2018 FCA database refresh, plus updates as capital renewal projects are completed and when changes to the remaining life of systems are identified. Actual expenditures through FY 2020 is approximately \$199M, encumbrances from FY 2020 not yet paid is \$58M, and additional budget for new projects in FY 2021 is \$121M. Capital renewal needs for additional FY 2021 projects are in scope development by the OCPS Program Management team.

#### Local Developing Business (LDB)

The Local Developing-Business program is the district's race-neutral small-business program. This program intends to support local small businesses (as defined by net profit and personal net worth limitations). These small businesses must be located locally within the Orlando Statistical Metropolitan area (Orange, Osceola, Lake, and Seminole Counties). The district has an overall goal of spending 10% with local developing businesses. Currently, the district has sub-contracted 4% LDB participation in construction and 21% LDB participation in professional services.

#### Veteran Business Enterprise (VBE)

The district implemented its Veteran Business Enterprise program in Fiscal Year 2016. The language encouraging participation was added to all procurement solicitation documents. In addition, vendors submitting proposals that included VBE sub-contractors/consultants on their team were awarded points in the selection process. The district has awarded several contracts directly to VBEs, including RL Burns, Blue Cord, Eagle 6 (IT) and several other VBEs. The district has received an overwhelmingly positive response from the Veteran community for its VBE program. The district has an overall goal of spending 3% with veteran-owned businesses. Currently, the district has sub-contracted 3% in construction and 4% in professional services.

District programs (MWBE, LDB, and VBE) support the district's goals of operational efficiency by increasing competition; and sustained community engagement by ensuring the inclusion of small businesses in the procurement process

#### <u>Outreach</u>

In support of the district's goal of Sustained Community Engagement, the Office of Business Opportunity (OBO) hosted and/or attended over 50 outreach events during Fiscal Year 2018. Outreach events provide meaningful interactions for members of the business community to network and gain additional information and insight on how to do business with the school district. In addition, the events allow OBO staff to share information about the district programs aimed at increasing purchasing with MWB, LDB, and Veteran- Owned Business enterprises (VBE).
